

Privacy policy of personal data

The real Privacy policy of personal data (further – Privacy policy) works for all information which the website Mf Center VIP Real estate agency in Spain, (further – Mf Center) multifunctional.center located on domain name (and also its subdomains), can receive about the User in usage time of the website multifunctional.center (and also its subdomains), its programs and its products.

1. Definition of terms

1.1 In the real Privacy policy the following terms are used:

1.1.1. "Administration of the website" (further – Administration) – authorized employees on management of the website Mf Center VIP Real estate agency in Spain who will organize and (or) carry out personal data processing and also defines the purposes of personal data processing, structure of the personal data which are subject to processing, actions (operation) made with personal data.

1.1.2. "Personal data" - any information relating to directly or indirectly to the certain, or defined natural person (the subject of personal data).

1.1.3. "Personal data processing" - any action (operation) or set of actions (operations) made with use of the automation equipment or without use of such means with personal data including collecting, record, systematization, accumulation, storage, specification (updating, change), extraction, use, transfer (distribution, providing, access), depersonalization, blocking, removal, destruction of personal data.

1.1.4. "Confidentiality of personal data" - the requirement, obligatory for observance by the Operator or other person who got access to personal data, not to allow their distribution without the consent of the subject of personal data or existence of other legal basis.

1.1.5. "The website Mf Center VIP Real estate agency in Spain" is a set of the web pages connected among themselves placed on the Internet on a unique address (URL): multifunctional.center and also its subdomains.

1.1.6. Subdomena are the pages or the set of pages located on domains of the third level belonging to the website Mf Center VIP Real estate agency in Spain and also other temporary pages, below which contact information of Administration is specified

1.1.5. "The user of the website Mf Center VIP Real estate agency in Spain" (further the User) – the person having access to the website Mf Center VIP Real estate agency in Spain, by means of the Internet and the Real estate agency using information, materials and products of the website Mf Center VIP in Spain.

1.1.7. "Cookies" — the small fragment of data sent by the Web server and stored on the computer of the user which the web client or the web browser sends every time to the Web server in a HTTP request in attempt to open the page of the corresponding website.

1.1.8. "IP address" — a unique network node address in the computer network through which the User gets access to Mf Center.

2. General provisions

2.1. Use of the website Mf Center VIP the Real estate agency in Spain by the User means consent with the real Privacy policy and conditions of personal data processing of the User.

2.2. In case of disagreement with Privacy policy conditions the User should stop use of the website Mf Center VIP Real estate agency in Spain.

2.3. The real Privacy policy is applied to the website Mf Center VIP Real estate agency in Spain. Mf Center does not control and does not bear responsibility for the websites of the third parties on which the User can follow the links available on the website Mf Center VIP Real estate agency in Spain.

2.4. The administration does not check personal data verification, provided by the User.

3. Privacy policy subject

3.1. The real Privacy policy sets obligations of Administration for nondisclosure and providing the mode of privacy protection of personal data which the User provides at the request of Administration at registration on the website Mf Center VIP Real estate agency in Spain or at a subscription to information to e-mail mailing.

3.2. The personal data allowed for processing within the real Privacy policy are provided by the User by filling of forms on the website Mf Center VIP Real estate agency in Spain and include the following information:

3.2.1. surname, name, User's middle name;

3.2.2. contact phone number of the User;

3.2.3. e-mail address (e-mail)

3.2.4. place residence of the User (if necessary)

3.2.5. photo (if necessary)

3.3. Mf Center protects Data which are automatically transferred at visit of pages:

- IP address;

- information from cookies;

- information on the browser

- access time;

- referer (address of the previous page).

3.3.1. Shutdown of cookies can entail impossibility of access to the parts of the website demanding authorization.

3.3.2. Mf Center carries out collecting statistics about the IP addresses of the visitors. This information is used for the purpose of prevention, identification and a solution of technical issues.

3.4. Any other personal information which is not stipulated above (visit history, the used browsers, operating systems, etc.) is subject to reliable storage and non-proliferation, except for the cases provided in Subparagraphs 5.2. real Privacy policy.

4. Purposes of collecting personal information of the user

4.1. The Administration can use personal user information for the purpose of:

4.1.1. User identifications, registered on the website Mf Center VIP Real estate agency in Spain for its further authorization.

4.1.2. Providing to the User access to the personalized data of the website Mf Center VIP Real estate agency in Spain.

4.1.3. Establishments with the User of feedback, including the direction of notices, the inquiries concerning use of the website Mf Center VIP Real estate agency in Spain, processings of inquiries and applications from the User.

4.1.4. Definitions of the location of the User for safety, prevention of fraud.

4.1.5. Confirmations of reliability and completeness of the personal data provided by the User.

4.1.6. Creations of the account for use of parts of the website Mf Center VIP Real estate agency in Spain if the User agreed to creation of the account.

4.1.7. Notifications of the User by e-mail.

4.1.8. Granting effective technical support to the User at emergence of the problems connected with use of the website Mf Center VIP Real estate agency in Spain.

4.1.9. Granting to the User from his consent of special offers, the newsletter and other data on behalf of the website Mf Center VIP Real estate agency in Spain.

5. Ways and terms of processing of personal information

5.1. Processing of personal user information is carried out without restriction of term, any lawful way, including in information systems of personal data with use of the automation equipment or without use of such means.

5.2. Personal user information can be transferred to authorized bodies of the government of the Russian Federation only on the bases and as it should be, the established legislation of the Russian Federation.

5.3. During the losing or disclosure of personal data the Administration has the right not to inform the User on loss or disclosure of personal data.

5.4. The administration takes necessary organizational and technical measures for protection of personal information of the User against illegal or accidental access, destruction, change, blocking, copying, distribution and also against other illegal actions of the third parties.

5.5. The administration together with the User takes all necessary measures for prevention of the losses or other negative consequences caused by loss or disclosure of personal user information.

6. Rights and obligations of the parties

6.1. The user has the right:

6.1.1. To make the free decision on providing the personal data necessary for use of the website Mf Center VIP Real estate agency in Spain and to agree to their processing.

6.1.2. To update, add the provided information on personal data in case of change of this information.

6.1.2. To update, add the provided information on personal data in case of change of this information.

6.1.3. The user has the right at Administration of information concerning processing of his personal data if such right is not limited according to federal laws. The user has the right to demand from Administration of specification of his personal data, their blocking or destruction in case personal data are incomplete, outdated, inexact, illegally received or are not necessary for a stated purpose of processing and also to take the measures for protection of the rights provided by the law. For this purpose it is enough to notify Administration to the address specified by E-mail.

6.2. The administration is obliged:

6.2.1. To use the obtained information only for the purposes specified in item 4 of the real Privacy policy.

6.2.2. To provide storage of confidential information in secret, not to disclose without prior written permission of the User and also not to carry out sale, exchange, publication, or disclosure of other possible ways of the transferred personal user information, except for Subparagraphs 5.2. real Privacy policy.

6.2.3. To take precautionary measures for protection of confidentiality of personal user information according to an order, usually used for protection of such information in the existing business conduct.

6.2.4. To carry out blocking of the personal data relating to the corresponding User from the moment of the address or inquiry of the User, or his lawful representative or authorized body on protection of the rights of subjects of personal data for check, in case of detection of doubtful personal data or illegal actions.

Responsibility of the parties

7.1. The administration which did not fulfill the obligations bears liability for damages, suffered by the User in connection with unauthorized use of personal data, according to the legislation of the Russian Federation, except for the cases provided by Subparagraphs 5.2. and 7.2. real Privacy policy.

7.2. In case of loss or disclosure of Confidential information the Administration does not bear responsibility if the given confidential information:

7.2.1. Became public property before its loss or disclosure.

7.2.2. It was received from the third party until its receiving the Resource by Administration.

7.2.3. It was divulged with the consent of the User.

7.3. The user bears full responsibility for observance of requirements of the legislation of the Russian Federation, including laws on advertizing, on protection of copyright and related rights, on protection of trademarks and service marks, but without being limited listed, including full responsibility for the content and a form of materials.

7.4. The user recognizes that responsibility for any information (including, but without being limited: files with data, texts, etc.) to which he can have access as to a part of the website Mf Center VIP Real estate agency in Spain, the person which provided such information bears.

7.5. The user agrees that information provided to him as a part of the website Mf Center VIP Real estate agency in Spain can be an intellectual property item, the rights for which are protected and belong to other Users, partners or advertisers who post such information on the website Mf Center VIP Real estate agency in Spain.

The user has no right to make changes, to lease, transfer on terms of loan, to sell, extend or create derivative works on the basis of such Contents (completely or in a part), except for cases when such actions were in writing directly allowed by owners of such Contents according to conditions of the separate agreement.

7.6. In the relation of text materials (articles, publications which are in free public access on the website Mf Center VIP Real estate agency in Spain) their distribution is allowed provided that the reference to Mf Center will be given.

7.7. The administration does not bear responsibility to the User for any loss or damage suffered by the User as a result of the removal, failure or impossibility of saving any Contents and other communication

data which are contained on the website Mf Center VIP Real estate agency in Spain or transmitted through it.

7.8. The administration does not bear responsibility for any straight or indirect losses which occurred because of: use or impossibility of use of the website, or separate services; unauthorized access to communications of the User; statements or behavior of any third party on the website.

7.9. The administration does not bear responsibility for any information posted by the user on the website Mf Center VIP Real estate agency in Spain, including without limitation: information protected by copyright without the direct consent of the copyright owner.

8. Settlement of disputes

8.1. Before appeal to the court with the claim for the disputes arising from the relations between the User and Administration obligatory presentation of a claim (the written offer or the offer in electronic form on voluntary settlement of a dispute) is.

8.2. The recipient of a claim within 30 calendar days from the date of receiving a claim, in writing or in electronic form notifies the applicant of a claim on results of consideration of a claim.

8.3. At not reaching an agreement the dispute will be submitted Arbitration court of of SPAIN.

8.4. The current legislation of the Russian Federation is applied to the real Privacy policy and the relations between the User and Administration.

9. Additional conditions

9.1. The administration has the right to make changes to the real Privacy policy without the consent of the User.

9.2. New Privacy policy comes into force from the moment of its placement on the website Mf Center VIP Real estate agency in Spain if other is not provided by new edition of Privacy policy.
